
Mike Bydalek

**Charles Baron** 

Charles Baron is co-founder of Farmers Business Network (FBN), where he has helped guide the development of the breakthrough farmer-to-farmer network since its inception. The FBN network's mission of increasing the prosperity of family farms through information, competition, and digital commerce has earned the support of over 120,000 member farms operating over 170 million acres in the United States and Canada with the backing of class investors such as GV (formerly known as Google Ventures), T. Rowe Price, and Temasek.

Started in 2014, FBN has grown to become ag's leading online provider of inputs, having made over 100,000 deliveries direct-to-farm—with primary product lines in crop protection, fertilizers, seed, livestock and farm supplies. FBN's finance arm, FBN Finance, has extended nearly \$3 billion in financing to producers for farmland, equipment and operating needs. The FBN sustainability platform has certified over 10,000 farms and paid over \$32 million in premiums to growers, and in 2024 was formed into a full joint-venture with Archer Daniel Midlands (ADM) under the Gradable brand. FBN aims to serve farms' full operating needs and reduce their costs as an online marketplace with the most efficient sources of capital, goods and services.

Previously, Mr. Baron was a program manager at Google, where he started and led product, investment and research initiatives in advanced energy technologies. His passion for farming developed after working a corn harvest on his brother-in-law's farm in Arapahoe, Nebraska prior to joining Google. Charles earned his bachelor's degree from Dartmouth and an MBA from Harvard.

Dr. Andy Benson

Andrew Benson received his Ph.D. in microbiology from the University of Texas Health Science Center at San Antonio in 1992, and he was a postdoctoral fellow in molecular biology at Princeton University from 1992-1996. He began his career at the University of Nebraska-Lincoln as an Assistant Professor in 1996 and is currently a Professor in the Department of Food Science and Technology. During the first half of his career at the University of Nebraska, Andrew's research focused on development and application of novel genome-based strategies for differentiating subpopulations of bacterial pathogens and understanding how their genetic diversity affects physiology, ecology and virulence characteristics. Later in his career, he began to study the human gut microbiome and is known for his work using complex trait analysis to show that species composition of the gut microbiome can be influenced by genetic variation in the host.

Tim Brummels has served for the past five years as the Chairman, CEO and President of Synbiotic Health. Tim has an extensive background as an entrepreneur, executive officer, board member and investor for natural health ingredient companies. He serves as a director of the Lower Platte South Natural Resources District, and he directs the Rural Law Opportunities Program at the College of Law. Professor Schutz graduated in 2003 from the Nebraska College of Law with the highest distinction and was editor-in-chief of the Nebraska Law Review. He then clerked for the Honorable C. Arlen Beam of the U.S. Court of Appeals for the Eighth Circuit until 2005.
